

**RESOLUTION #01032023-1
TRANSFERRING FUNDS WITHIN FUNDS
FROM ONE DEPARTMENT BUDGET CLASSIFICATION TO ANOTHER**

WHEREAS, it is necessary to transfer funds from one budget classification to another within the Clerk-Treasurer's Office of the City of New Castle; and
